RESOLUTION SETTING DATE FOR A PUBLIC HEARING ON THE APPROVAL OF A TAX ABATEMENT RESOLUTION FOR THE PURPOSE OF FINANCING PUBLIC INFRASTRUCTURE

WHEREAS:

1. The City of Halstad has determined it necessary and feasible to construct public improvements on Highway 75 and to help with costs associated with the Safe Routes to School project within its corporate limits; and

2. The City Council intends to abate its share of property taxes on adjacent parcels benefiting from the project to finance the costs constructing said improvements, under the authority of Minnesota Statutes 469.1812 to 469.1815 (the "Abatement Law"); and

3. Prior to approving an abatement resolution and the use of tax abatement the City must hold a public hearing.

BE IT RESOLVED by the City Council as follows:

1. Public Hearing. The City Council shall hold a public hearing on the use of tax abatement and the issuance of general obligation tax abatement bonds to finance the costs of constructing improvements on Highway 75 and to help with costs associated with the Safe Routes to School project at 5:15 p.m. on Monday, March 11, 2019 at the Halstad Community Center. Staff is directed to publish notice of this hearing as required by Abatement Law.
