

Notice of Mail Ballot Procedures Norman County, Minnesota

A. The following precincts located in Norman County have elected to vote by mail ballot procedure in statewide elections as authorized under MN Statutes 204B.45. All other precincts vote at their designated polling place on Election Day.

B. For 2024 statewide elections, the election dates and the corresponding dates that ballots will be mailed for the foregoing mail ballot precincts are:

Statewide Primary Election: August 13, 2024 Ballot Mailing Dates: June 28–August 13, 2024
Statewide General Election: November 5, 2024 Ballot Mailing Dates: September 20– November 5, 2024

C. Each voter registered by July 23, 2024 for the Statewide Primary Election, and/or October 15, 2024 for the Statewide General Election will be mailed a ballot automatically.

D. Ballots may be returned by mail (a postage prepaid return envelope is included when the ballots are mailed), or may be delivered in person, or delivered by designated agent to the Norman County Auditor-Treasurer's Office, 16 3rd Ave E, PO Box 266, Ada, MN 56510. Ballots must be received no later than 8:00 p.m. on Election Day in order to be counted. Normal business hours are Monday - Friday, 8:30 a.m. to 4:30 p.m.

In addition to the normal business hours, extended hours for mail ballot voting are:

Statewide Primary Election:

- Saturday, August 10, 2024, from 9:00 a.m. to 3:00 p.m.;
- Monday, August 12, 2024, 8:30 a.m. to 5:00 p.m.;
- Tuesday, August 13, 2024, 7:00 a.m. to 8:00 p.m.

Statewide General Election:

- Saturday, October 26, 2024 from 9:00 a.m. to 3:00 p.m.;
- Tuesday, October 29, 2024 from 8:30 a.m. to 7:00 p.m.;
- Saturday, November 02, 2024 from 9:00 a.m. to 3:00 p.m.;
- Sunday, November 03, 2024 from 9:00 a.m. to 3:00 p.m.;
- Monday, November 04, 2024, from 8:30 a.m. to 5:00 p.m.;
- Tuesday, November 05, 2024, from 7:00 a.m. to 8:00 p.m.

E. Eligible voters not pre-registered by the dates noted in item C above, or pre-registered voters wishing to receive their ballot at a temporary address may contact the Norman County Auditor-Treasurer's Office by phone, mail or in person for an absentee ballot application. Call 218-784-5471 for further information.

F. All mail ballots will be counted at the Norman County Courthouse after 8:00 p.m. on the respective election dates.
