

**Notice of Mail Ballot Procedures Norman County, Minnesota**

The following precincts located in Norman County have elected to vote by mail ballot procedure in statewide elections as authorized under MN Statutes 204B.45. All other precincts vote at their designated polling place on Election Day. Precincts that can vote at the Courthouse on Election Day from 8 a.m. to 8 p.m.:

For 2026 statewide elections, the election dates and the corresponding dates that ballots will be mailed for the foregoing mail ballot precincts are:

Statewide Primary Election: August 11, 2026                      Ballot Mailing Dates: June 26–July 14, 2026  
Statewide General Election: November 3, 2026                      Ballot Mailing Dates: September 18–October 6, 2026

Each voter registered by July 21, 2026 for the Statewide Primary Election, and/or October 13, 2026 for the Statewide General Election will be mailed a ballot automatically.

Ballots may be returned by mail (a postage prepaid return envelope is included when the ballots are mailed), or may be delivered in person, or delivered by designated agent to the Norman County Auditor-Treasurer's Office, 16 3<sup>rd</sup> Ave E, PO Box 266, Ada, MN 56510. Ballots must be received no later than 8:00 p.m. on Election Day in order to be counted. Normal business hours are Monday - Friday, 8:30 a.m. to 4:30 p.m.

In addition to the normal business hours, extended hours for mail ballot voting are:

Statewide General Election:                      Saturday, October 24, 2026, 9:00 a.m. to 3:00 p.m.;  
    Tuesday, October 27, 2026, 8:30 a.m. to 7:00 p.m.;  
    Saturday, October 31, 2026, 9:00 a.m. to 3:00 p.m.;  
    Sunday, November 01, 2026, 9:00 a.m. to 3:00 p.m.;  
    Monday, November 02, 2026, 8:30 a.m. to 5:00 p.m.;  
    Tuesday, November 03, 2026, 7:00 a.m. to 8:00 p.m.

Eligible voters not pre-registered by the dates noted above, or pre-registered voters wishing to receive their ballot at a temporary address may contact the Norman County Auditor-Treasurer's Office by phone, mail or in person for an absentee ballot application. Call 218-784-5471 for further information.

All mail ballots will be counted at the Norman County Courthouse after 8:00 p.m. on the respective election dates.
